**Qualification for Assistant Professor:**

**Eligibility**

- A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET :

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfilment of the following conditions:-

- The Ph.D. degree of the candidate has been awarded in a regular mode;
- The Ph.D. thesis has been evaluated by at least two external examiners;
- An open Ph.D. viva voce of the candidate has been conducted;
- The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal;
- The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/ supported by the UGC / ICSSR/ CSIR or any similar agency.

**Qualification for Junior Accountant:**

**Essential:** Graduate in Commerce/Economics and other related subjects dealing with financial management from a recognized University.

**Qualification for Store Keeper Gr. II:**

- Must have passed 12<sup>th</sup> Standard or equivalent examination from a recognized Board.

- 03 years experience of procurement/Inspection Maintenance and verification of Stores in a Govt./Semi Govt. organization or a Private Organization of repute

**Qualification for TGT (Mathematics & Hindi)**

**Essential:**

1. Four Years Integrated Degree Course of Regional Institute of Education of NCERT or any other Institute recognized by the Government in the concerned subject with at least 50 % Marks in aggregate.

**OR**

- Bachelor's Degree with atleast 50% marks in aggregate and in the concerned subjects and B.Ed. or equivalent qualification from recognized University.
2. Pass in the Central Teacher Eligibility Test (CTET), conducted by CBSE in accordance with the Guidelines framed by the NCTE for the purpose.
  3. Proficiency in Teaching in Hindi and English medium.

**Desirable - Knowledge of Computer Applications.**

**Qualification for WETs (Agriculture)**

**Essential:**

1. Four Years Integrated Degree Course of Regional Institute of Education of NCERT or any other Institute recognized by the Government in the concerned subject with at least 50 % Marks in aggregate.

**OR**

- Bachelor's Degree with atleast 50% marks in aggregate and in the concerned subjects and B.Ed. or equivalent qualification from recognized University.
2. Proficiency in Teaching in Hindi and English medium.

**Desirable -**

- 1 Knowledge of Computer Applications.
- 2 Preference will be given to the candidates having experience or qualification or both in the field of Horticulture.

Candidates who fulfil the above eligibility conditions may attend the walk-in-interview with their application in the following format with a recent passport size photograph and original testimonials, proof of age, caste certificate in r/o SC/ST/OBC and produce a set of self attested copies of testimonials for scrutiny one hour before the commencement of the interview.
