The firm/agency was asked to provide security guards as per Institute requirement and obey all the rules and regulations , guidelines, instructions which are given by the Institute time to time and mentioned in the their tender documents, agreements, various letters, e-mails, notices, warring letter etc.

8/8/2022, 26/8/2022, as well as issued Show Cause Notice vide reference No. 2-164/C&W/SS/RIEA/2021-22/1756-1762 dated 11/7/2022 asking for explanation informing about provisions of the clause rule & term conditions No. 1, 14, 23, 27, 28, 31 (c), 50, 57, 58, 59 (2) & 25.

Ltd., 5-E, First Floor, Jungi House, ShahpurJat, New Delhi – 110049 replied against show cause notice on dated 11/07/2022 through mail wherein firm/agency (Head & VP) informed that due to some unavoidable reasons we are unable to provide the adequate supervisions, as well as due to un avoidable reasons we are unable to provide trained guards, given assurance at S.No. 10 & 13 that we will timely disburse the wages & salaries every month.

WHEREAS Regional Institute of Education, NCERT, Ajmer (Raj) sent letter to firm/agency vide no. 2-164/RIEA/C&W/SS/ORION SECURITY/2021-22/3462-72 dated 15/11/2022 asked to clear all the dues, wages, salaries, short payments etc. on or before 17/11/2022 but firm/agency has submit replied mentioning that Delay in salary: due to some unprecedented issue of the firm. Minimum wage not paid: we would pay the arrear payment to the manpower along with their Nov'2022 month wages. Non provision of uniform: This is to ensure that uniform issue will get close by/before 23.11.2022.

WHEREAS Regional Institute of Education, NCERT, Ajmer (Raj)Institute's has put all the possible efforts to give agency sufficient time, regular intimation, phone calls to all the possible higher authorities of agency, e-mails ,meeting etc., but the agency still the agency is found not in position to clear all the dues, salaries, wages, dress etc. to security guards deployed in RIE, Ajmer by M/s. Orion Security Solutions Pvt., Ltd, New Delhi.
