Qualifications for Assistant Professor:

Essential:

- Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university. (Relaxable as per UGC rules in respect of reserved categories)
- Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- Notwithstanding anything contained in sub-clauses (i) and (ii) to this Clause, candidates, who are, or have been awarded a Ph.D. Degree in accordance with the U.G.C. (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent position in Universities/Colleges/Institutions.

Exemption of NET is permissible to the candidates who have -

- obtained M.Phil Degree on or before 10th July 2009.
- obtained Ph.D. Degree on or before 31st December 2009.
- registered for Ph.D. on or before 10th July 2009 and subsequently awarded the Ph.D. Degree.

- NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET in not conducted.

Desirable:

- B.Ed./M.Ed. for all posts of Assistant Professors.

Candidates who fulfill the above eligibility conditions may attend the walk-in-interview with their application in the following format with a recent passport size photograph and original testimonials, proof of age, caste certificate in r/o category and produce a set of self attested copies of testimonials for scrutiny one hour before the commencement of the interview.

Important Instructions:

1. Application form only in the prescribed format will be considered.
2. The number of posts mentioned above is tentative. However, number of posts may be increased or decreased at any stage
3. The age relaxation in respect of candidates belonging to SC/ST/OBC/PWD/WOMEN categories is provided in accordance with the GOI/UGC rules.
4. No TA/DA, Local conveyance etc. will be paid for attending the interview.
5. Merely fulfilling the minimum eligibility conditions does not constitute a claim for selection.
6. Institute reserves the right to cancel/postpone the recruitment process at its discretion.
7. Offer of appointment will also be sent through E-mail only.
8. Separate application is required for different post.
9. The contractual engagement will confer no right to claim the post on regular basis.
10. The engagement will be made as per the need of the Institute.
11. The Institute reserves the right to terminate the contractual engagement at any time without assigning any reason thereof.
